Dear Ms. Tourangeau:

During the review of the above-noted application materials, Department staff identified an area of project work on Perkins Road and require information on the notice given to abutters in this area.

Drawing CU100 – Utility Context Plan (and further detailed on CU109 – Sanitary Sewer Connection Plan – Perkins Road) shows a proposed sewer force main that would convey the project’s domestic wastewater to the City of Belfast Wastewater Treatment Facility for processing. The plans show that the sewer force main would be installed in the Perkins Road right of way (approximately 1,240 feet long) and run from an easement near the western edge of the Goldenrod Properties, LLC parcel to the intersection of Perkins Road and Northport Avenue, where it would connect to an existing sewer manhole in Northport Avenue.

Chapter 2 §1(A) of the Department’s rules defines an abutter as a person who owns property that adjoins the delineated project boundary, including owners of property directly across a public or private right of way. If our understanding of the proposal for sewer force main work in Perkins Road is correct, this would be part of the proposed project, and property owners along Perkins Road would be entitled to receive public notice pursuant to Section 1(A). We therefore ask that you provide evidence that the abutters on the north side of Perkins Road have been sent public notice of the application.
