Dear Mr Graham and Mr. White:

On June 19, 2018, Mallinckrodt US LLC filed a Petition for Modification of the Board of Environmental Protection's Order of August 19, 2010, governing remediation of the former chlor-alkali manufacturing facility in Orrington. Mallinckrodt's Petition invokes the process set forth in Chapter 2, Sections 26 and 27, of DEP's rules, 06-096 C.M.R. ch. 2 §§ 26 & 27, and requests that the Commissioner recommend to the Board that it initiate a proceeding to consider the proposed modification.

The Maine Peoples Alliance (MPA) and the Town of Orrington (the Town) were parties to the adjudicatory hearing that produced the Board's Order of August 19, 2010, and on June 21, 2018, DEP provided MPA and the Town with copies of Mallinckrodt's Petition via email. If you wish to file a response to Mallinckrodt's petition for the Commissioner's consideration, please do so by 5:00 PM on July 23, 2018. After reviewing the Petition and any responses you submit by COB July 23, 2018, the Commissioner will either dismiss the Petition or recommend to the Board that it initiate modification proceedings, all in accordance with Chapter 2, Sections 26 and 27. 06-096 C.M.R. ch. 2 §§ 26 & 27.
