On January 15, 2016 I issued technical review comments<sup>1</sup> related to several sections of the Juniper Ridge Landfill Expansion Application. During a January 30, 2016 meeting Department staff discussed my comments with NEWSME, the State of Maine's Bureau of General Services (BGS) and Sevee & Maher, Inc. (SME). In response, on behalf of the Bureau of General Services and NEWSME, Sevee & Maher, Inc. (SME) prepared a March 2016 document<sup>2</sup> containing detailed responses to all of my January 15, 2016 review comments. I reviewed the March 2016 response to comment document and subsequently prepared an additional technical review memorandum which contained my follow-up comments<sup>3</sup>. Before BGS and NEWSME prepared the second round of

response to comments, Department staff met with BGS, NEWSME and SME on May 6, 2016 to discuss the comments outlined in my April 1, 2016 review memorandum. The May 13, 2016 document contains BGS and NEWSME's responses to my April 1, 2016 response to comments memorandum and is the subject of this memorandum.

## Comments

I have carefully reviewed BGS and NEWSME's May 13, 2016 response to comment document. I find the detailed comments and additional information included in the submittal satisfactorily addresses all of my outstanding concerns. Additionally, it is important to note SME's recent submittal regarding the supplemental bedrock evaluation has satisfactorily addressed my concerns about the need to complete additional bedrock explorations within the proposed expansion footprint. This information augments the current understanding of groundwater flow in the fractured bedrock beneath and in the immediate vicinity of the proposed landfill expansion. The results of this evaluation provided useful additional hydrogeological data that will further improve the proposed bedrock monitoring well network.
